### Hire Houston First



- Purchases of Personal Property (Goods): Awarded to local business within 3% of lowest bid received if contract value is \$100,000 or greater
  - Within 5% of lowest bid received if contract value is under \$100,000
- Purchases of Services\*: Within 3% of the lowest bid if contract value is \$100,000 or greater
  - Within 5% of the lowest bid if contract value is under \$100,000
- Purchases Under \$50,000: No more than 5% greater than the lowest bid



### **OBO Solution Center**



- Resource Center
- Assists companies with navigating the City's licensing and permitting process
- Provides business development, networking activities, and access to various contracting opportunities
- Collaborates with partners such as banks, educational institutions, local chambers, government agencies, and trade organizations
